Lasting Legacies

Vessels of Philanthropy

While Agneta and John Solomon worked in Ecuador for their respective countries, Sweden and the United States, their love for each other, the country, and pre-Colombian art blossomed. They soon married and settled in the United States, where John practiced law and Agneta raised their two daughters. But the Solomons continued to visit South America whenever their busy lives allowed them to explore art from this region.

The Solomons began to think about updating their will to include the Cleveland Museum of Art. They wished to be more engaged with the museum and with Susan E. Bergh, chair of the Department of the Art of Africa and the Americas and curator of Pre-Columbian and Native North American Art. In 2013 Bergh visited the Solomons at their home in Wadsworth, Ohio, to view their collection of pre-Colombian and Ecuadorian art. Over the next several years, John and Agneta generously provided the funds for Bergh to make two significant acquisitions: a Sea Lion Pup Vessel made 200–450 AD by the Moche people of the Central Andes and a Vessel with Reclining Figure and Birds made 2200–200 BC in the Cupisnique style.

Sadly, about the time the museum acquired Vessel with Reclining Figure and Birds, John passed away. But the Solomons had made plans in their estate to continue to demonstrate their affection for the museum and Bergh. Through their plan,

created in collaboration with Bergh and Director of Philanthropy Diane Strachan, many other acquisitions will be realized. Agneta continues to be engaged at the Cleveland Museum of Art. The ways that John and Agneta have partnered with the museum throughout the years have provided meaningful resources for which we are deeply grateful.
